The Board also discussed ways we could possibly detect such leaks sooner in the future including perhaps reading meters more than once per month so we wouldn't have such a long amount of time between readings to go by.

The cpa report looked good. Everything seems to be running smoothly.

Danny made a motion to pay the approved monthly bills and Robert seconded the motion. All were in favor. Motion passes.
